A motion was made by Annette Jones, seconded by Dub Yarbrough, to submit the Drainage Policy in final form to all local public bodies and specify that they should appoint a designee and implement the Drainage Policy by June 15, 1994. Roll call vote: Dub Yarbrough, yes; Guy McDowell, yes; Annette Jones, yes; John Chaney, yes. Motion passed 4 to 0.
